## RECORDING OF SATURDAY PENNANT RESULTS

Two recorders will be in attendance at Association Headquarters from 4.00pm until 6.00pm on Saturdays to record results and thus enable publication of ALL pennant results in the Sunday Papers & Newcastle Herald. Results should be telephoned/faxed to the Association Office immediately after the completion of play.

Clubs have been placed alphabetically in two sections for recording purposes. From **A to M** i.e., **ADAMSTOWN TO MORISSET HOSPITAL**, have been allotted 4929 3441 and **N to W** i.e., **NELSON BAY TO WINDALE/GATESHEAD**, have been allotted 4929 1307.

Results are to be given by stating:-

1. HOME CLUB
2. GRADE AND SECTION
3. SHOTS SCORED BY HOME CLUB
4. SHOTS SCORED BY VISITING CLUB
5. MATCH POINTS GAINED - WINNING SIDE FIRST

In order that the number of phone calls be kept to a minimum, it will be necessary for clubs to APPOINT ONE PERSON TO PHONE THE RESULTS OF ALL MATCHES PLAYED AT THE HOME CLUB. It must be appreciated that should individual team managers phone in results of their particular matches the number of calls would become unmanageable.
