ORDER OF BUSINESS

- a) The roll of clubs shall be called by the Administrator before proceeding with any other business. Each delegate shall be required to record his attendance.
- b) Confirmation of Minutes of the Previous Annual Meeting and of any Special Meetings held during the year.
- c) Consideration of the Annual Report, Balance Sheet and the Auditor's Report.
- d) Declaration of Ballot for Officers and Permanent Sub-Committees.
- e) Appointment of Auditor who shall be a Registered Public Accountant.

NOMINATION FOR OFFICERS & PERMANENT SUB-COMMITTEES

Should nominations fall short of the required number those nominated shall be declared elected and nominations for the vacant positions shall be called from the floor of the meeting and if needed a ballot shall be held to determine the successful nominees.
