NDBA/ZONE 2 – REPRESENTATIVE PLAYERS/OFFICIALS CODE OF CONDUCT

This Code of Conduct will be binding on all players/officials chosen to represent NDBA/Zone 2.

Your signature on this document indicates that you agree to be bound by and comply with all conditions set out in the document. You also understand that disciplinary action may be taken against any player/official who breaches the conditions set out below. Initial disciplinary action may be taken by Team Management during the event. If the matter is considered of a serious nature then the player/official shall be required to appear before a Judicial Committee convened by the NDBA/Zone 2 Executive.

Team Management includes the Team Manager, Selectors, the Player Co-Captains for the event and the NDBA/Zone 2 President or his nominee.

This form must be signed by yourself as a player/official and then witnessed by another member of the NDBA/Zone 2. One copy is to be returned to the NDBA and the other copy is to be kept for yourself.

Failure to return or sign the form will result in non-selection or withdrawal from representative fixtures.

CODE OF CONDUCT – CONDITIONS

1. I am first and foremost an ambassador for NDBA/Zone 2 and at all times I will conduct myself in an exemplary and responsible manner both on and off the green. I will not engage in any harassment, discrimination, vilification or conduct liable to bring NDBA/Zone 2, its Players or Officials into disrepute prior to, during or after an event (including Social Media).
2. I will treat other players/officials with dignity and respect.
3. I will be aware of the itinerary for events and abide by instructions from Team Management in relation to:
 - Arrival time for all games and practice sessions.
 - Attendance at all team meetings.
 - Attendance at social gatherings of the team each day.
 - Any curfew set during an event.

4. I will always perform to the best of my ability and work equally hard for myself and the team irrespective of the position I have been selected to play.
5. I will be responsible in relation to the consumption of alcohol and ensure that such consumption does not affect my own or the team's performance.
6. I will not possess, take or use any prohibited drugs at any representative event.
7. I will comply with the travel and accommodation arrangements for the team and any variation must be in writing and requires the approval of Team Management.
8. I will treat any property with care and respect and I acknowledge that, should I be in breach of this undertaking, I will be liable to pay any damages arriving therefrom.
9. When on the green I will only wear attire that is the appropriate NDBA/Zone 2 uniform.
